The Emperor responded that Colonel McCracken had been an active participant in the Mid Devon Sector since 2003 and spoke of his military experience; he spoke also of Hawkins' term as Vorsitzender of Abelden, and of both nominated judges' experience as secondary Adammic delegates to the GUM and colonial governors, and their legislative experience on Adammia's former Colonial Council and in Abelden.
