Tuesday 24th September STATEMENT – **Opening of nominations for Speaker** *His Imperial Majesty Emperor Adam I*

H.I.M. Emperor Adam I (LMP)

Honourable members of the House of Citizens, welcome and congratulations on your election.

As Lord Chancellor, and therefore responsible for constitutional implementation, and in the absence of any standing orders, I will be overseeing the election of the Speaker of the House. Nominations are now open and will close on Thursday. Be advised that I am nominating myself for this position. Be further advised that, due to the small size of the House and the knife-edge arithmetic, we do not presently expect the Speaker to be neutral, as this would risk putting the House in deadlock.

I am also going to begin drafting the Standing Orders of the House. If any members are interested in helping in drafting the SOs, then let me know and a working group can be formed to that effect.

Nominations for Speaker should be PM'd to me.

Lord Juliano Saunders (STM)

What are the duties of the Speaker?

H.I.M. Emperor Adam I (LMP)

To preside over the business of the House and to adjudicate on matters of order.

Lord Colonel Asher Bond (STM)

If the Speaker is not going to be impartial then I suggest they should be a member of the opposition to prevent the Government from having too much power?

Lord Juliano Saunders (STM)

Agreed.

H.I.M. Emperor Adam I (LMP)

An impartial speaker, as I would assure hon. members I would be, would give no more power to either the government or the opposition. The notion that you believe the Speaker being a member of the government gives it more power implies that you believe that the Speaker being a member of the opposition would give the opposition more power. Neither of these things are supposed to be the case. I have chaired the Ruling Council impartially for six years despite my party membership. As Speaker, whilst I would retain the right to vote down party lines, I would not restrict debate on either side of the House. Anyone who has been to a Ruling Council meeting knows that I allow members of all parties to make their voice heard.

Lord Juliano Saunders (STM)

I am satisfied with this assurance. I still believe the Emperor should not have political affiliations, that is a discussion for another time though.

H.I.M. Emperor Adam I (LMP)

Honourable members of the House of Citizens, nominations for Speaker of the House are now closed.

I have received a nomination for Lord Sam Maude. I should also inform that House that I have withdrawn my own nomination.

I have had many, many disagreements with [Lord] Maude, but he is an honourable man who will stand for justice and fairness in the house of citizens! Was very happy to see [H.I.M. the Emperor] step down upon noticing he simply is not popular enough in the house. We need less Adam and more Adammia!

H.G. Lady Sophie Thornton (LMP)

I have called [Lord] Maude my good friend for many years - from on the same side beyond Adammia and across the floor within it. He knows how to respectfully disagree and promote equality and fairness.
